5.1 Extinguishing media:

Suitable extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. Under Annex VI to Regulation (EC) No 1272/2008 Trimethoxyvinylsilane (VTMO) is classified for skin sensitization category 1B based on in vivo studies in laboratory animals. However, after occupational exposure no allergic reactions have been reported.

Mixtures of VTMO (up to 5% active ingredient) have been investigated in the local lymph node assay (OECD 429). None of the investigated mixtures showed a sensitizing potential. Therefore, this product has not been classified as H317, Skin sensitisation Category 1B, as determined by expert judgement.
